A limited number of half and full scholarships are available. Scholarships **must be recommended, and the form submitted by FRYSC coordinator**. (*Homeschooled youth: Please turn application in directly to the Fayette County Extension Office*) Scholarships are based on financial need and are competitive. All scholarship applications **MUST be received by Fayette County Extension Staff no later than 4:30 p.m. Thursday, May 15, 2025**. Recipients will be notified by May 20th. STEP 1: Make sure the camper section of this application is complete. Attach additional narrative if needed.

STEP 2: Turn THIS scholarship application in to FRYSC Coordinator at your school for them to finish and forward to the Extension Office by the deadline of May 15th, 2025.

- If you are RELATED to your FRYSC Coordinator, please have Principal complete.
- If you are HOMESCHOOLED, please complete and turn it in directly to the Extension Office.

NOTE: DO NOT GIVE THE FRYSC COORDINATOR THE ENTIRE CAMPER APPLICATION. Give ONLY THE SCHOLARSHIP APPLICATION (this page) to FRYSC Coordinator.

STEP 3: **Turn the Camper Application and \$50.00 deposit in at the Fayette County Extension Office (1140 Harry Sykes Way, 40504)**. Please notify 4-H that you have turned your child's scholarship application in to your FRYSC Coordinator when you drop off your Camper Application.
